Stetner Electric returned with a quote of \$3150.00 plus sales tax to complete the miscellaneous electrical upgrades around the station. Work will move forward to have Stetner Electric complete the work.

MES was on-site and complete some necessary repairs to the district's breathing air compressor system and it is not functioning correctly.

Old Business:

B-255H Project – Tank production update was provided, and the tank should be built and received by the district by late Fall. DNR is going to provide the district with an additional \$5000.00, which can be used towards the truck buildout. Quotes were review from General Fire and MES for the needed water pump. Tanneberg made a motion to proceed with ordering the pump through MES for the quoted \$18,751.65 and Buckingham concurred. Motion carried.

New Business:

Discussion was held in regards the possibility of the district acquiring a used road grader from Douglas County. The initial proposal is the possibility of the county providing the
